

Michigan Saves Contractor Qualifications

All contractors must meet the minimum qualifications described in the table below and provide the appropriate documentation to be considered by Michigan Saves. An application for participation is not a guarantee of authorization, even if a contractor meets the minimum qualifications. Michigan Saves reserves the right to deny a contractor's application at any time, if staff believes that a contractor's business practices are not a good fit for Michigan Saves' programs.

State of Michigan Business License	Corporations and LLC's must be registered and in good standing with the State of Michigan Corporations Division. If the company is incorporated under the laws of a state other than Michigan, then it must be registered and in good standing with the State of Michigan Corporations Division for at least 12 months. Sole proprietors and limited liability partnerships do not have to register their business with the State of Michigan.

Staff may also perform a basic internet search of the company and its owners/principals to determine if there are any outstanding or past legal claims, including but not limited to bankruptcy proceedings, material liens, criminal convictions, and civil judgments against the company and its owners/principal, or a history of consumer complaints, or unsavory allegations about the company, the owners/principals, or the company's work product. Michigan Saves staff will also evaluate the company's fit for our programs. Michigan Saves reserves the right to deny a company's application, even if it meets the minimum qualifications for participation, if staff believes that the company's business or sales practices are not a good fit for Michigan Saves and present a reputational risk.
